### Filipino Language and Culture (Jun Pioquinto)

### **Merchant POS Terminal to Accept Credit Card Payments**

Jun: it would be nice to Fil-Am to have a way to accept credit cards. However, we need to consider the merchant charges that will be incurred by adding this service.

Lorelei: We might look into integration of a merchant with MembershipWorks Andrei: We should look into merchants and find a competitive service that will allow us to accept credit card payments.

Chel will gather and compare the costs of different credit card merchant services.

### **File for Small Claims**

It might be more prudent to not file for small claims against any former board members, as filing a claim may cause more issues down the line. We will continue to attempt to re-gain control of the previous Fil-Am Portland Facebook Page.
